



Lamar Women's Lacrosse 2017 Team Uniform Agreement

- Property of HISD/Lamar Women's Lacrosse:** Team uniform consists of one white skirt, one navy skirt and 2 jerseys (white & navy). Additionally, the team captains or coaches might call for the Nike 2-in-1 shorts or the Under Armour navy practice shorts to be worn in a game(s). In order to reduce the financial burden on players' families, the uniforms are checked out by players and shall remain the property of HISD/LWLAX with the exception of the shorts which have been purchased and are not returned. I understand that the uniforms (jerseys and skirts) are property of HISD for the benefit of the Lamar Women's Lacrosse Club and are intended to be worn for multiple seasons. Further at the end of the season, I will return the complete uniform in good condition.
- Deposit Check:** I understand that my deposit check is required to check out the uniform for the 2017 lacrosse season: \$50 refundable deposit and \$25 rental fee. *Circle one:*

NOTE: Parents are responsible for any financial obligations to HISD incurred by their student. This includes lost books, lost calculators or classroom materials, lost or unreturned sports equipment (including uniforms), damage to property, etc. Failure to account for financial obligations may result in your student being unable to participate in athletic or extracurricular activities, school related functions, denied access to your student's report cards, etc.

- Care of Uniform:** I understand that I am responsible for the care of the uniform, which is as follows:
 - Always wash uniform inside out in cold water.
 - Hang to dry.
 - Do not use fabric softener
 - Do not use an iron on the uniform. It will ruin the uniform.
- Return of Uniform:** It is my responsibility to return the complete washed uniform, all in good condition and in condition in which it was received, except for normal wear and tear, in a timely manner at the end of the season. I understand that the complete washed uniform shall be returned at the end of the season or in the event I leave the Lacrosse Club before the end of the 2016 season. I will receive a \$50.00 deposit refund with the return of my uniform.
- Replacement Costs of Not Returned/ Missing Uniforms:** The cost of the complete uniform is \$210. The parents and player understand that they are responsible for the actual replacement costs including taxes, if any and shipping for any unreturned items. In the event that any of the pieces of the uniform are not returned or are missing, the full deposit fee shall be applied towards the replacement costs for the unreturned or missing pieces(s). The parents and player are responsible for and shall remit to LWLAX for the remaining portion of the replacement costs.
