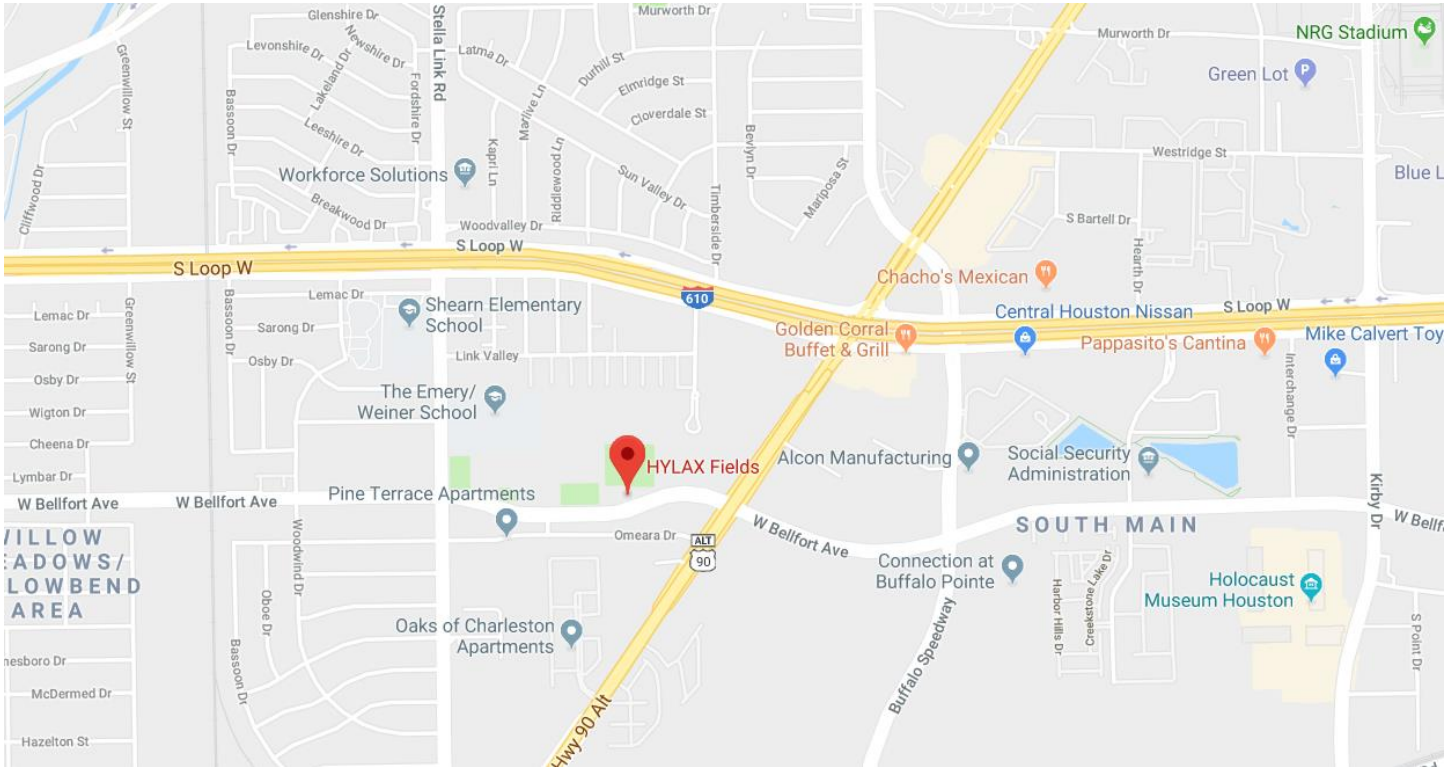
Directions:

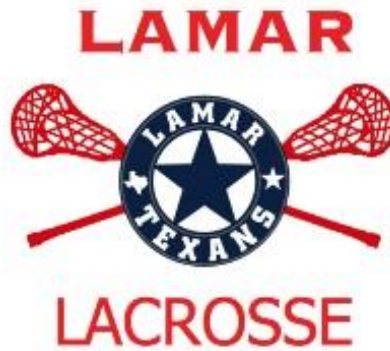
